Addendum to Clause 25.5

The existing Clause 25.5 of the Cadre Recruitment Rules for Non-Teaching Posts, Regulations, 2025 shall be read with the following addition:

"Qualifying in Typing Test/Skill Test with knowledge of computers shall also be the compulsory requirement for promotion to the post of Library Assistant."

This Addendum is issued to maintain uniformity with the Model Cadre Recruitment Rules of UGC as adopted by the University for the post of Library Assistant, which have been created in Central Sanskrit University, subsequently to adoption CRR-2025.

This Addendum shall come into force with immediate effect from the date of issue of this notification.
