#### **ORDER**

Whereas, the institution Central Sanskrit University, Sree Sadashiva Campus, Plot No.- 19, 20, Street No. Chandan Hazuri Road, Vill./P.O./Town/City- Puri, Tehsil/Taluka- Puri, Dist.- Puri, Odisha- 752001 (Code No. APE00431 & APE00972 & ERCAPP4019) was granted recognition for conducting Shiksha Shastri (B.Ed.) course of one year duration with an annual intake of 60 students vide ERC's order no. F.No.OR-SO/E-3/97/6262 dt. 22.06.1998. Thereafter, permission was granted to the institution from the academic session 2005-2006 vide ERC's order no. ERC/7-56.5.5/2005/1484(7) dt. 12.05.2005 with an addl. intake of 40 students, thus making the total intake of 100 students (two basic units). Thereafter, permission was granted to the institution from the academic session 2009-2010 vide ERC's order no. ERC/7-100.6(1)(1S).4/2009/1372 dt. 31.08.2009 with an addl. intake of 27 students, thus making the total intake of 127 students.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide ERC's order no. F. ERC/NCTE/APE00431 & APE00972/ Shiksha Sastri(B.Ed.)(Revised Order)/2015/32770 dt. 31.05.2015 for conducting Shiksha Shastri (B.Ed.) course of two years duration with an annual intake of 150 (three basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- And whereas, permission was granted to the institution from the academic session 2017-2018 vide ERC's order no. F.ERC/NCTE/APE00431 & APE00972/Shiksha Sastri (B.Ed.)(Revised Order)/2015/ 32770 dt. 31.05.2015 with an addl. intake of 50 students, thus making the total intake of 200 students (four units).
- And whereas, the ERC in its 278th meeting held on 16th 18th January, 2020 considered the matter and decided as follows:-
  - (i) List of teaching faculty is not appointed as per NCTE Regulation, 2014.
  - (ii) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. (Shiksha Sastri) course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

Accordingly, recognition was withdrawn, u/s 17(1) of the NCTE Act, 1993, vide order no. F.No. ER-278.52/APE00431 & APE00972 & ERCAPP4019/B.Ed.(Shiksha Shastri)/2020/62149 dt. 28.01.2020 from the academic session 2020-2021.

- And whereas, the institution preferred an appeal to the NCTE Hqrs. Against the withdrawal order dated 28.01.2020 and the Appellate Authority vide order no. 89-210/E-166409/2020 Appeal/23rd Mtg.-2020/22<sup>nd</sup> October, 2020/94995 dt. 20.11.2020 remanded back the case to the ERC with a direction to consider the faculty list, to be submitted to them by the appellant and take further action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC, the staff list submitted in appeal and also proof for updating their website with the requisite information within 15 days of receipt of orders on the appeal.
- And whereas, the institution has submitted a reply dated 28.12.2020 and the ERC in its 288th meeting held on 29th January, 2021 considered the reply submitted by the institution alongwith original

regulatory file & other related documents, NCTE Act, 1993, Regulations & Guidelines issued by NCTE from time to time and decided as under:-

- (i) The change of name of the college from 'Rashtriya Sanskrit Sansthan' to 'Central Sanskrit University' is accepted.
- (ii) Restoration of Recognition Order of Shiksha Shastri (B.Ed.) course to be issued in the name of Central Sanskrit University, Sree Sadashiva Campus, Plot No. 19, 20, Street No. Chandan Hazuri Road, Vill/Po/Town/City-Puri, Tehsil/Taluka-Puri, Dist.-Puri, Odisha-752001.
- 7. Now therefore, recognition withdrawn vide order dt. 28.01.2020 of Central Sanskrit University, Sree Sadashiva Campus, Plot No.- 19, 20, Street No. Chandan Hazuri Road, Vill./P.O./Town/City-Puri, Tehsil/Taluka- Puri, Dist.- Puri, Odisha- 752001 (Code No. APE00431 & APE00972 & ERCAPP4019) for conducting Shiksha Shastri (B.Ed.) course of two years duration with an annual intake of 200 students (four units) is hereby restored from session 2021-2022.
- 8. The terms and conditions of the order No. F. ERC/NCTE/APE00431 & APE00972/Shiksha Sastri(B.Ed.)(Revised Order)/2015/32770 dt. 31.05.2015 issued to the institution shall remain same.
